#### 1. Consider changes to the Supplemental Declaration for Three Springs Townhomes

The Directors discussed the request by the purchaser of Buena Vida townhomes (nine townhomes) for an amendment to the Supplemental Declaration for Three Springs Townhomes to withdraw these townhomes from the Supplemental Declaration for Three Springs Townhomes. KP made a motion to approve the amendment. JP seconded the motion. TZ abstained due to a Conflict of Interest per the "Three Springs Master Association Policy and Procedure Regarding Conflicts of Interest" adopted on January 31, 2007. The motion was passed and unanimously carried by the disinterested directors.

#### 2. Consider the transfer of the common elements of the townhomes on Buena Vida Ave.

The Directors discussed the transfer of the common elements of the townhomes on Buena Vida Ave. to the purchaser. JP made a motion to approve the transfer. KP seconded the motion. TZ abstained due to a Conflict of Interest per the "Three Springs Master Association Policy and Procedure Regarding Conflicts of Interest" adopted on January 31, 2007. The motion was passed and unanimously carried by the disinterested directors.

## 3. <u>Conflict of Interest disclosure by Tim Zink concerning Home Occupation Application</u> submitted by Lacey Johnston on April 5, 2017

TZ disclosed that issues have been raised regarding his daughter Lacey Johnston's application for approval of a home occupation. TZ then excused himself from the remainder of the meeting.

KP and JP confirmed that TZ recused himself on March 29, 2017 from reviewing and/or approving Lacey Johnston's Home Occupation Application per the "Three Springs Master Association Policy and Procedure Regarding Conflicts of Interest" adopted on January 31, 2007. The nature of the Conflict of Interest in this case was due to TZ's position as President of the Three Springs Associations Board of Directors at the time and the fact that Lacey Johnston is TZ's daughter.

KP and JP confirmed that Lacey Johnston submitted her Home Occupation Application to the Three Springs Residential Association on April 5, 2017. The application was approved by the disinterested members of the Three Springs Residential Association Board on April 11, 2017.

# 4. Ratification of Three Springs Residential Association approval of Home Occupation Application on April 11, 2017 (submitted by Lacey Johnston on April 5, 2017 per #3 above)
